PER CURIAM: 1 In September 1991, Petitioner filed in this Court a petition for a writ of habeas corpus pursuant to 28 U.S.C.s 2254 (1988 & Supp. II 1990). Petitioner was removed from the judgment and sentence under which he is being held, and he remains in the custody of the Virginia Department of Corrections. We deny the petition for the following reasons. 2 Petitioner requests the appointment of counsel to represent him on this petition. The plain language of 28 U.S.C. § 2254 does not authorize the appointment of counsel, and we have held that there is no constitutional right to appointment of counsel for state prisoners who file habeas corpus petitions. See Winstead v. Johnson, 708 F.2d 865, 868 (5th Cir. 1983). Thus, it is clear that Petitioner is not entitled to the relief he requests. 3 We note that Petitioner already has filed a civil suit seeking relief from his state court conviction.
